### **IFCA Support Service**

The Irish Foster Care Association's Support Service offers independent and professional support in fostering situations. The aim of the service is to offer the best support during difficult times to make the process clearer and easier for all involved.

## Life after Caring Project

Through its support service, IFCA deals with an average of one thousand cases a year. Issues relating to allegations, placement disruptions and support for birth children feature prominently. The sense of grief and loss is a predominant theme identified by those who respond to callers to IFCA's National Support Helpline and by IFCA's National Support Volunteers. Loss has been identified as integral to, and an on-going component of fostering. Therefore, looking after foster carers during these processes promotes a healthy life after caring.

IFCA has identified a number of elements to the Life after Caring Project as follows:

- The design and delivery of workshops and development of leaflets/booklets that incorporate
  practical strategies for participants to integrate into their lives. Content will include dealing
  with grief and loss specifically, and emotions associated with same; self-compassion
  techniques; promoting resilience and positivity; emotional intelligence; communication
  techniques; introduction to mindfulness and meditation.
- 2. The provision of access to a counselling service that will allow for ongoing professional support to be offered to those who have identified their own individual support needs, but require more guidance over a prolonged and consistent basis.
- 3. The third component focusses, with the involvement of other organisations, on the establishment of educational modules, as well as a sustainable therapeutic support system for children of foster carers who have experienced loss as a result of their experience of foster care.

This project was approved by Government with support from the Dormant Accounts Fund



# **Therapeutic Support Co-ordinator Role**

The Therapeutic Support Co-ordinator will work with the Heads of Services within IFCA to coordinate and deliver on this project in 2018.

# **Key Responsibilities:**

- Development of "Life after Caring" Workshop content and leaflets/booklets in conjunction with IFCA Heads of Learning and Development, and Support Service
- Co-ordination of the 'Life after Caring' Project in conjunction with the IFCA Head of Support and wider IFCA Team
- Oversee the design, implementation and evaluation of the project in conjunction with the Head of Support and wider IFCA Team
- Facilitation of workshops nationwide
- Evaluation of workshops nationwide
- Liaise with IFCA's management and Heads of Services in relation to relevant aspects of the Project
- Assist in the development of other aspects of the project.
- Maintain records relating to all aspects of the work
- Maintain professional requirements to all aspects of the work
- Liaise with external stakeholders in relation to the pilot

- In conjunction with the Heads of Learning and Development and Support, develop a train the-trainers course to train others in the delivery of workshops developed as part of the Project in the future on behalf of IFCA.
- Assist in the recruitment of mental health professionals for counselling for foster carers
- Ensure IFCA's quality indicators for the all services are adhered to.
